- > Delivering by hand
- > Posted (by registered post or recorded delivery or special delivery post) so that in the normal course of post it might be expected to be delivered by the date stated or
- > Faxed and an acknowledgement of the fax kept (fax no. 0141 287 5357) or
- > Emailed and an acknowledgement of the email kept (LicensingBoard@glasgow.gov.uk)

It is the responsibility of the person making the objection or representation to ensure that the Licensing Board has received it.

Any person making an objection or representation to this application should be aware that their correspondence will be copied to the Applicant in accordance with Section 22(3)(a) of the Licensing (Scotland) Act 2005. In providing the Applicant with a copy of the correspondence the Licensing Board will redact (remove) certain personal information such as telephone numbers or domain names in email addresses relating to the author; however the name and address of the person making the objection or representation will be provided to the Applicant.
