Variation proposes to a) add off sales facilities Monday to Sunday 11.00am to 10.00pm; b) extend the on sales terminal hour from 12 midnight to 1.00am on Monday to Sunday; c) amend the seasonal variations; d) permit bar meals, indoor/ outdoor sports, televised sports and outdoor drinking facilities within and outwith core licensed hours; e) allow live performances within core licensed hours; f) add take away, deliveries, Santa's grotto and Christmas market to additional activities; g) allow accompanied Children and Young persons access to the premises until 11pm or the end of a meal or function and unaccompanied young persons access until 11pm; h) add off sales alcohol display of 4.8m2; i) amend the internal layout of the premises to include a bar area and general reconfiguration; j) amend the layout of the premises to include an external areas to the side of the premises for 42 persons and the front of the premises on Ingram Street for 14 persons. k) increase the overall capacity from 135 persons to 191 persons; and l) amend the premises description to read: 'The premises operates predominantly as a restaurant in the city centre with external areas.'
