GLASGOW'S POPULATION BY ETHNICITY

An Analysis of 2011 Census Results

1 INTRODUCTION

- 1.1 On 30th September 2014, the Council's Regeneration and the Economy Policy Development Committee discussed a report "Demographic Changes in Glasgow City and Neighbourhoods", which gave the results, for Glasgow, of 2011 Census data release 2. The report informed Committee of DRS plans to submit three topic papers, following the release of more detailed Census data (release 3) by National Records of Scotland (NRS). The present briefing paper is the first of these topic papers and presents 2011 Census results in relation to Glasgow's population by ethnicity.
- 1.2 Earlier, on 12 December 2013, a briefing paper was published "Population by Ethnicity in Glasgow, Estimates of Changes 2001-2011 for Strategic Planning Areas and Neighbourhoods". That paper was based on *population numbers* by ethnicity from 2011 Census data release 2.
- 1.3 2011 Census release 3 contains *more detailed information*, which enables an analysis of demographic characteristics for the various ethnic groups, as well as of their housing and employment conditions. However, in order to prevent individuals to be identified in Census information, NRS have applied disclosure control checks before publishing any Census Tables. For the 2011 Census, NRS have been very strict in the application of their procedures. This has reduced some of the detail available. For example, in some Census Tables NRS have reduced the ethnic groups to a few amalgamated categories and this has reduced the scope of the analysis possible.
- 1.4 The ethnicity question in the 2011 Census has changed relative to the question in the 2001 Census form. The main differences are:
 - "Gypsy/Traveller" and "Polish" as additional sub-categories for the "White" population.
 - "African" as a separate category, instead of as a sub-category under "Black, Black Scottish or Black British".
 - "Arab" as an additional sub-category for the "Other ethnic group" population.

Any comparison with 2001 Census data needs to take into account these changes in the Census question.

1.5 The Scottish Government has published an analysis of equality results from the 2011 Census in two papers: <u>http://www.gov.scot/Publications/2014/10/8378</u> and <u>http://www.gov.scot/Publications/2015/03/8716</u> These papers contain a chapter on "Ethnicity", but focus on the results at a Scotland level (although some comparisons at Council level are included).

- 1.7 The present Briefing paper focuses on the results for Glasgow and compares these with the Scotland results. These comparisons, as well as comparisons over time, focus on the three main categories: "British White", "Other White" and "BME". Information on the variation of characteristics for the groups within these categories is given by Diagrams within the main text and via Tables in the Appendix.
- 1.8 In the Briefing Paper referred to above (see paragraph 1.2) the "White Irish" population has not been included in the definition of the "Other White" population. In this paper, however, the "Other White" category represents all White ethnic groups that are not either Scottish and/or British and therefore it includes the "White Irish". This is consistent with the analysis undertaken by the Scottish Government (see paragraph 1.5).
- 1.9 The "Other White" category contains the sub categories "White Irish", "White Gypsy/Traveller", "White Polish" and "White Other". In the text of this paper the term "Other White" includes all these sub categories. It should be distinguished from the term "White Other", which refers only to the sub category within "Other White".
- 1.10 Within the BME population, the "Other Ethnic group" is sub divided into "Other ethnic Arab" and "Other ethnic Other". In the text of this paper "Other Ethnic" includes both sub categories and "Other ethnic Other" refers only to the latter of the two sub categories.
- 1.11 It is important to draw attention to *the diversity both between the ethnic groups and within the ethnic group populations*. This means that, at an individual level, there is no justification to make assumptions on population characteristics (e.g. religion and national identity) solely from membership of a particular ethnic group.
- 1.12 Initial analysis of the 2011 Census results on ethnicity in Glasgow was undertaken by Egle Pugaciauskaite, a student from Glasgow University, who worked as an intern with the Council in Summer 2014. The valuable contribution that she made is hereby acknowledged. It should be noted that Egle is not responsible for any of the content of this Briefing Paper.
- 1.13 A word of thanks is also due to NRS Customer Services who have helpfully provided some additional Census Tables to assist the analysis undertaken.
- 1.14 In the main text any numbers have generally been rounded to the nearest 100 and percentages are given with one decimal. Background data for the main text and the Diagrams is provided by Tables A1 to A48, in the Appendix.

2 MAIN RESULTS

Demography

Total Population Numbers

- 2.1 In 2011, 17.3% of Glasgow's population belongs to an ethnic minority, with "Other White" groups at 5.8% and BME groups at 11.6%. This compares with ethnic minorities making up 8.2% of Scotland's population, with "Other White" groups at 4.2% and BME groups at 4.0%.
- 2.2 The recent growth in Glasgow's population of 15,400 between 2001 and 2011 is due to rising population numbers for Glasgow's ethnic minority groups ("Other White" +12,400 and BME +37,200). Over that period the "British White" population fell by 34,200.
- 2.3 The "Other White" population has grown substantially in Glasgow through the influx of migrants from Poland and other European countries. 8,400 people in Glasgow identified themselves as "White Polish" in the 2011 Census.

Location

- 2.4 Calton is the neighbourhood with the highest "Other White" population gain. There were significant increases in the "Other White" population for neighbourhoods north and south of the River Clyde: from Broomhill and Greater Govan in the West, to Greater Gorbals and Tollcross/West Shettleston in the East.
- 2.5 South Nitshill/Darnley is the neighbourhood with the highest BME population gain. There were large increases in the BME population for neighbourhoods from North to South: from Springburn, Sighthill/Roystonhill and Ruchill/ Possilpark, via Yorkhill, City Centre and Calton, to Ibrox/Kingston, Greater Gorbals, Pollokshields East and Govanhill.

Composition BME Population

2.6 Since 2001, there has been a change in the composition of Glasgow's BME population. Despite a rise in the *number* of Pakistani, the *share* of Pakistani in Glasgow's BME population fell from 48.7% in 2001 to 32.6% in 2011. This is accounted for by above average rises for the African and "Caribbean or Black" populations (from 5.7% in 2001 to 20.7% in 2011) and the Chinese population (from 12.3% in 2001 to 15.6% in 2011).

Age

2.7 Glasgow's ethnic minorities have a younger age profile than the "British White" Population. Ethnic minority rates are much higher for children and young adults: 22.6% of children (age 0-15) and 24.2% of young adults (age 16-29) belong to an ethnic minority, compared to an all-age figure of 17.3%.

For the older age groups ethnic minority rates are much smaller. Ethnic minorities make up only 6.4% of the population for the age group 60 and over.

Religion

- 2.8 The main changes in the population distribution by religion for Glasgow City in 2001 and 2011 are (1) an increase in the number of people with no religion (from 131,200 in 2001 to 183,800 in 2011), (2) a reduction in the number people belonging to the Christian religion (from 374,400 in 2001 to 323,000 in 2011 and (3) an increase in the number of people belonging to another religion (from 27,500 in 2001 to 44,400 in 2011).
- 2.9 The religious profile for Glasgow's BME population is very different from that of Glasgow's White population. The number of BME people with no religion (at 16.5%) is half the City average (at 31.0%). Only 19.8% of Glasgow's BME population belongs to the Christian religion (Glasgow: 54.4%), but 57.9% belongs to another religion (Glasgow: 7.5%).
- 2.10 The change in the ethnic composition of Glasgow's BME population has had an impact on its' religious profile. The main change is an increase for those identifying as "Christian" (from 10.0% in 2001 to 19.8% in 2011) and a reduction for those identifying as "Muslim" (from 53.3% in 2001 to 44.4% in 2011). This is related to the rise in Glasgow's African population, of whom 62.2% identify themselves as "Christian".

National Identity

- 2.11 80.3% of Glasgow's population consider themselves as having a Scottish identity (Scotland: 82.7%).
- 2.12 8.3% of Glasgow's population have only a non-UK identity (Scotland 4.4%). This higher number, as compared with Scotland, is due to a higher BME population in Glasgow.
- 2.13 34.7% of Glasgow's BME population consider themselves as having a Scottish identity, 27.0% have a non-Scottish UK identity and 38.2% have only a non-UK identity. These figures are comparable with those for the BME population in Scotland.

Country of Birth

- 2.14 In Glasgow, the share of the population who are born outside the UK rose from 5.7% in 2001 to 12.2% in 2011. This compares with a rise, for Scotland, from 3.8% in 2001 to 7.0% in 2011.
- 2.15 The rise, for Glasgow, in the number of people "born abroad" is mainly due to the increase in the "Other White" and BME populations. The percentage "born abroad" is 69.6% for the "Other White" population and 62.5% for the BME population, as compared with only 1.2% for the "British White" population.

<u>Health</u>

Health Problem or Disability

- 2.16 In 2011, 10.5% of Glasgow's BME population has a long term illness or disability. This limits day-to-day activities "a little" for 5.8% and "a lot" for 4.7% of the population. These rates are around half the rates for the City, at 22.7%.
- 2.17 Another Census question asked details on specific health conditions. In Glasgow the percentage of the population with one or more long term health conditions is 33.5% for the "British White", 19.8% for the "Other White" and 15.2% for the BME population.
- 2.18 For the "White Scottish", "White Irish" and "White Gypsy/Traveller" groups in Glasgow more than 30% of the population have one or more long term health conditions. The "White Polish" have the lowest rate, at 9.3% of the population.

General Health

- 2.19 In Glasgow the rate of poor health (defined as the percentage of people who have rated their health as either "bad" or "very bad") is highest for the "British White" population (9.7%) and lower for the "Other White" population (4.2%) and BME population (3.7%).
- 2.20 Rates of poor health are highest in Glasgow for "White Gypsy/Traveller" (14.0%) and "White Scottish" populations (10.0%).

Provision of Unpaid Care

2.21 The percentage of those who provide unpaid care is highest in Glasgow for the "British White" population (9.8%) and lower for the "Other White" population (5.6%) and BME population (5.9%).

Observation on Comparisons

- 2.22 The comparisons above do not take into account the (generally) younger age profiles of Glasgow's ethnic minorities, as compared with the "British White" population. Some of the more positive health results for ethnic minorities may therefore be due to the effect of a different age composition.
- 2.23 Some analysis for Scotland, undertaken by the Scottish Government (see paragraph 1.6), has employed age-standardised rates, to compare people of similar age. The results of that analysis show that most ethnic groups in Scotland reported better health than the "White Scottish" ethnic group. However, health concerns were identified for "White Gypsies/Travellers", older "White Polish" people and older Indian, Pakistani and Bangladeshi women.

<u>Housing</u>

Household Type

- 2.24 More than half of the increase in "all-student" households (at 3,500 in 2001-2011) is due to rises in ethnic minority households ("Other White": 400 and BME: 1,500).
- 2.25 Overall, the number of single adult households is lower for Glasgow's ethnic minority households (38.2% for "Other White" and 34.6% for BME, compared with 44.3% for "British White"). There is considerable variation: numbers are higher for "Caribbean or Black" (67.9%) and African (48.7%) and lower for Pakistani (19.2%) and "White Polish" (24.4%).
- 2.26 23.0% of households in Glasgow's are households with dependent children or (lone parent and other) families. For the BME groups the percentage is much higher, at 38.1%. The percentage of families is highest among Pakistani (55.9%) and "Other ethnic Arab" (46.5%).
- 2.27 Among ethnic minority groups there are relatively more households of adults without a family relation living together. Numbers are highest for Chinese, Bangladeshi, Indian, "White Polish" and "White Other".
- 2.28 For the total BME population only 25.0% of family households are lone parent households (City average: 40.4%). Numbers are lowest for Asian and Arab groups. Lone parent households make up more than 50% of family households for African and "Caribbean or Black" groups.

Housing Tenure

- 2.29 There was a sizable rise in the number of private rented households in Glasgow: +28,100 between 2001 and 2011. 40% of this rise is due to rises for the "Other White" (+4,500) and BME (+6,600) population groups.
- 2.30 17.7% of households in Glasgow in 2011 are private renters. Of "British White" households, only 14.7% are in private rented accommodation. The rates are much higher for "Other White" (37.6%) and BME groups (34.7%).
- 2.31 For individual ethnic groups the highest rates of private renting are: "White Other" (54.4%), Indian (47.9%), "Other Asian" (42.0%) and "Other Ethnic" (41.3%).
- 2.32 36.7% of households in Glasgow in 2011 are in social rented accommodation. The percentages are lower for "Other White" (27.2%) and marginally lower for "BME" groups (33.9%).
- 2.33 The ethnic groups with the lowest rates of social renting are: Indian (10.5%), "White Other British" (15.7%) and "White Other" (16.8%). The groups with the highest rates are: African (69.1%), "White Polish" (50.8%), "Caribbean or Black" (45.3%) and "White Scottish" (38.8%).

Occupancy rate

2.34 Ethnic minorities in Glasgow are more likely to live in overcrowded accommodation. Rates of overcrowding are over 30% for the Asian, African and "Other Ethnic" groups (City average: 17.4%).

Central Heating

2.35 Central heating is a function of dwelling type and tenure. In Glasgow 62.8% of BME households have gas central heating. This compares with 76.5% of households for the White population. For African households only 47.7% have gas central heating and 41.1% have electric central heating.

The Economy

Economic Status

- 2.36 23,500 out of Glasgow's 64,400 Full-Time students belong to an ethnic minority (36.4%: 11.1% "Other White" and 25.3% BME). Including the Full-Time students in Glasgow's population increases the ethnic minority share from 15.0% to 17.3%. In the remainder of this section economic activity rates are examined for the population age 16+ *excluding students*.
- 2.37 For the "**British White**" **population** economic activity rates (males 66.6%, females 58.3%) are somewhat lower than the City average (males 68.6%, females 58.9%). This is mainly due to more people in retirement or being "long term sick" and is likely to be affected by the older age profile for that population group.
- 2.38 Economic activity rates are above the City average for the "**Other White**" **population** (males 81.6%, females 72.5%), as there are fewer people in retirement or "long term sick". There are significantly more people in full time employment or self-employed and fewer male people are unemployed.
- 2.39 For the **BME population**, economic activity rates (males 80.3%, females 62.7%) are considerably above the City average for males and slightly above the City average for females. Relatively fewer people are in full time employment, with more people self-employed, unemployed, "looking after home" or "other economically inactive". Relatively fewer people are retired or "long term sick".
- 2.40 For many Asian groups the percentage in employment is considerably different for males and females. Correspondingly, for these Asian groups there are relatively more females who "look after home" or are "other economically inactive".
- 2.41 Fewer males from Asian groups, except Indian, are in full-time employment and relatively higher numbers are in part-time employment or are selfemployed.

2.42 For the African and "Caribbean or Black" groups the pattern is very different from the Asian groups, with relative numbers of employed people close to the City average and relatively higher numbers of unemployed for both males and females.

Qualifications

2.43 "Other White" and BME groups have, on average, higher qualifications than the "British White" population. A higher percentage of students and a younger age profile of ethnic minorities are factors which could explain this finding.

Socio-Economic Class and Occupation

- 2.44 A higher BME rate for the long term unemployed reflects higher numbers of unemployed for some BME groups, particularly the African and "Other Ethnic" groups.
- 2.45 A higher BME rate for small employers and own account workers is consistent with higher numbers of self-employed among some BME groups.
- 2.46 BME groups, with the exception of African, do well in terms of population share for the managerial and professional occupations. The BME rate is high for "sales and customer service" occupations due to higher numbers from the Asian groups. Similarly, the BME rate is high for elementary occupations, due to higher numbers from the African group.

Industry

- 2.47 BME rates are higher for the following industries: wholesale and retail trade (more Asian people), accommodation and food service activities (more Asian and other ethnic groups), information and communication (more Mixed and Asian groups), administrative and support service activities (more African and "Caribbean or Black" people) and human health and social work activities (more African and "Caribbean or Black" people).
- 2.48 BME people are under-represented in the following industries: manufacturing (fewer Asian and other BME people), construction, public administration and defence, and education (fewer Asian, African and "Caribbean or Black" people).

More detailed analysis

2.49 In the 2014 Annual Review of Demographic Trends in Scotland, the Registrar General has given a more detailed analysis, at a Scotland level, of how Scotland's ethnic groups fare in the Labour Market (see paragraph 1.6). The results of the analysis are consistent with the above findings. In addition to these, it was found that (1) "White Gypsy/Traveller people were much more likely to have never worked or to work in elementary occupations and (2) "White Polish" people are more likely to be in lower skilled employment.

3 DEMOGRAPHY

Total Population Change Glasgow City




Figure 3.1 – Population by Ethnicity for Glasgow City in 2011

- 3.1 In 2011, 17.3% of Glasgow's population belongs to an ethnic minority, with "Other White" groups at 5.8% and BME groups at 11.6% (see Figure 3.1).
- 3.2 This compares with ethnic minorities making up 8.2% of Scotland's population, with "Other White" groups at 4.2% and BME groups at 4.0%.

- 3.3 Table 3.1 (see next page) gives the population breakdown for the various ethnic groups in Glasgow and a comparison with figures for Scotland. There is a higher population share for the "Other White" and the BME groups in Glasgow, as compared with the Scottish average.





Figure 3.2 – Population Change by Ethnicity for Glasgow City in 2011 to 2011

- 3.4 Between 2001 and 2011 Glasgow's population rose by 15,400. The "British White" population fell by 34,200, but the numbers for the "Other White" and BME groups rose by 12,400 and 37,200 respectively (see next page, Figure 3.2). The recent growth in Glasgow's population is therefore due to rising population numbers for Glasgow's ethnic minority groups.
- 3.5 The population growth in Scotland was 233,400 in the period 2001 to 2011. This can be split into a rise by 30,000 in the "British White" population, a rise by 94,000 in the "Other White" population and a rise by 109,300 in the BME population.


Total Population Change for Neighbourhoods in Glasgow City

3.6 Map 1 below gives the total population change in 2001-2011 for Glasgow's 52 neighbourhoods. Within Glasgow City, population growth in 2001-2011 was focused on the neighbourhoods north of the River Clyde (from Broomhill to Calton) and on the Greater Pollok area. Population losses were highest in Sighthill/Roystonhill and in Easterhouse.





- 3.7 Maps 2, 3 and 4 (see next pages) give the component contribution to the total population change in 2001-2011 from the "British White" population (see Map 2), from the "Other White" population (see Map 3) and from the BME population (see Map 4).
- 3.8 The component contribution relates the population change in the component to the total population in 2001. For example, the change in the BME population for Riddrie and Cranhill (420, from 42 in 2001 to 462 in 2011) is related to the total population in 2001 (11,001), which gives a component contribution of +3.8% (= 420/11,001).
- 3.9 The *component contribution* gives a better indication of the impact of a change in the component (e.g. the BME population) on the total population than the *percentage change in the component*. The latter could give the impression of a massive change in areas where numbers were low in 2001 (e.g. in Riddrie and Cranhill the BME population was only 42, resulting in a 1000% increase in 2001-2011).

3.10 Map 2 below gives the component contribution to the total population change in 2001-2011 from the "British White" population. The highest population losses were in Sighthill, Springburn, Balornock and Easterhouse in the North and in Ibrox/Kingston, Govanhill, Toryglen, Pollokshaws and Arden/ Carnwadric in the South. The "British White" population increased by more than 4% in Carmunnock, Pollok and South Nitshill/Darnley in the South and in Broomhill, City Centre, Calton and Robroyston in the North.



- 3.11 Map 3 (see next page) gives the component contribution to the total population change in 2001-2011 from the "Other White" population. Calton is the neighbourhood with the highest population gain. There is a general pattern of increases in the "Other White" population for neighbourhoods north and south of the River Clyde: from Broomhill and Greater Govan in the West, to Greater Gorbals and Tollcross/West Shettleston in the East.
- 3.12 Map 4 (see next page) gives the component contribution to the total population change in 2001-2011 from the BME population. South Nitshill/ Darnley is the neighbourhood with the highest population gain. There is a general pattern of large increases in the BME population for neighbourhoods in the North to neighbourhoods in the South: from Springburn, Sighthill/ Roystonhill and Ruchill/Possilpark, via Yorkhill, City Centre and Calton, to Ibrox/Kingston, Greater Gorbals, Pollokshields East and Govanhill.





Changes in Composition of Glasgow's Ethnic Minorities' Population





Figure 3.3 – BME population by Ethnic Group in Glasgow in 2001 and 2011

3.13 The composition of Glasgow's ethnic minorities' population has changed considerably since 2001. Figure 3.3 (see below) shows the changes for the BME population.

- 3.14 In 2001 nearly half of Glasgow's BME population were Pakistani. Despite a rise in the *number* of Pakistani, from 15,300 in 2001 to 22,400 in 2011, the *share* of Pakistani in Glasgow's BME population fell from 48.7% in 2001 to 32.6% in 2011. This is accounted for by rises in the African and "Caribbean or Black" populations (from 1,800, or 5.7% of the BME population, in 2001 to 14,200, or 20.7% of the BME population, in 2011) and in the Chinese population (from 3,900, or 12.3% of the BME population, in 2001 to 10,700, or 15.6% of the BME population, in 2011).
- 3.15 Specifically, the high population share for Pakistani is particular to Glasgow. In 2011 3.8% of Glasgow's population has a Pakistani ethnicity. This compares with an all-Scotland figure of 0.9% (see Table 3.1).
- 3.16 As a share of the BME population in Scotland, the Pakistani population fell from 31.3% in 2001 to 23.4% in 2011.
- 3.17 As a share of the BME population, the Chinese population rose from 12.3% to 15.6% in Glasgow between 2001 and 2011 and remained constant in Scotland at 16.0%.
- 3.18 As a share of the BME population, the African and "Caribbean or Black" populations rose between 2001 and 2011 from 5.7% to 20.7% in Glasgow and from 7.9% to 17.1% in Scotland.
- 3.19 The "Other White" population has grown substantially through the influx of migrants from Poland and other European countries. The number of "White Irish" people has reduced. Recent research using the Scottish Longitudinal Study has found that some of the change is caused by switches of ethnicity. For example, a person who identifies as "White Irish" in 2001 may identify as "White Scottish" in 2011.

Large(r) Ethnic Minority Groups by Location

- 3.20 The following paragraphs indicate where the larger ethnic minority groups in Glasgow (those making up at least 1% of the City's total population) are living within the City.
- 3.21 There are relatively higher numbers of "White Irish" in parts of Glasgow South (Cathcart, King's Park, Croftfoot, Toryglen, Govanhill and Greater Gorbals) and in the West End (Yorkhill, Hillhead, Hyndland and Broomhill).
- 3.22 The highest proportion of "White Polish" (5.2%) is in Arden/Carnwadric. There are relatively higher numbers in Greater Govan, Ibrox/Kingston and in neighbourhoods east of the City Centre: Calton, Parkhead, Tollcross and West Shettleston.
- 3.23 The "White Other" group includes many (non-UK born) Europeans and Americans. The main concentrations of this group are found in the City Centre and the West End (Hillhead, Yorkhill/Anderston, Hyndland/Partick, Kelvinside/ Kelvindale, Maryhill Road Corridor and Broomhill).

- 3.24 For the Indian group the highest numbers are in Yorkhill/Anderston, Ibrox/ Kingston and Pollokshields. Above average numbers live in the City Centre and Kelvindale, as well as in South Nitshill and Darnley.
- 3.25 The largest concentration of "Pakistani" is in Pollokshields, where around onethird of residents are Pakistani. Also, higher numbers live in Govanhill, South Nitshill/Darnley, Arden/Carnwadric, Ibrox/Kingston, and Shawlands. These neighbourhoods are all in Glasgow South. Hillhead and Woodlands is an area north of the River Clyde, where the number of Pakistanis is higher than the City average.
- 3.26 The highest numbers of "Chinese" live in Yorkhill/Anderston, the City Centre, the West End (Hillhead and Kelvinside) and in Glasgow North (Sighthill/ Roystonhill, Ruchill/Possilpark, Springburn and Robroyston).
- 3.27 The largest concentrations of Africans are in Sighthill/Roystonhill and Springburn. Also, higher numbers live in Yoker/Scotstoun and in the following neighbourhoods south of the River Clyde: Greater Gorbals, Toryglen, Pollokshields and Ibrox/Kingston.

Population by Age and Gender




Figure 3.4 - Population by Age and by Ethnicity for Glasgow in 2011

- 3.28 Generally, Glasgow's ethnic minorities are younger than the "British White" Population (see Figure 3.4 on next page). Compared to an all-age figure of 17.3%, ethnic minority rates are much higher for children and young adults. For children (age 0 to 15) the ethnic minority rate is 22.6% ("Other White" 4.0% and BME 18.6%). For young adults (age16 to 29) ethnic minorities make up 24.2% of the population ("Other White" 8.6% and BME 15.6%). For the older age groups ethnic minority rates are much smaller: 6.4% for the age group 60 and over ("Other White" 3.7% and BME 2.8%).
- 3.29 For Scotland the same pattern of a younger ethnic minority population can be observed, albeit at a lower scale. Compared to an all-age figure of 8.2%, ethnic minority rates are higher for children (at 9.0%) and young adults (at 13.9%). Again, ethnic minority rates are much smaller for the older age groups: 3.0% for the age group 60 and over.
- 3.30 As well as looking at ethnic minority rates for a given age band, it is also possible to compare the age profiles for the different ethnic groups. Figure 3.5 (see next page) shows that the "White Scottish" and "White Irish" populations have an older age profile. The following groups have a considerably younger age profile: "Mixed ethnic groups", Chinese, "Other ethnic Arab", African and "White Polish".
- 3.31 Compared with Scotland, Glasgow has a higher number of young adults. The people aged 16-44 make up 46.2% of Glasgow's population (in Scotland: 38.4%).




Figure 3.5 - Population by Ethnicity and by Age for Glasgow in 2011

- 3.32 The "White Other British" living in Glasgow tend to be younger than those living elsewhere in Scotland. The age-group 16-44 makes up 64.3% of the "White Other British" population in Glasgow (in Scotland: 39.8%).
- 3.33 In Glasgow, the proportion of young adults (age 16-29) is particularly high for the Chinese, at 52.4% (in Scotland: 46.4%).

3.34 51.8% of people in Glasgow are female (Scotland: 51.5%). This reflects the position for the White population. The situation is different for most of the BME groups, where only 47.4% of people are female (only the Chinese and "Mixed ethnicity" people have more females than males)

Population by Religion





Figure 3.6 – Population by Religion for Glasgow in 2001 and 2011

- 3.35 Figure 3.6 above gives the population distribution by religion for Glasgow City in 2001 and 2011. The main changes are an increase in the number of people with no religion (from 131,200 in 2001 to 183,800 in 2011), a reduction in the number people of the Christian religion (from 374,400 in 2001 to 323,000 in 2011 and an increase in the number of people belonging to another religion (from 27,500 in 2001 to 44,400 in 2011).
- 3.36 Compared with Scotland, in Glasgow there are (1) relatively fewer people with no religion (Glasgow: 31.0%, Scotland: 36.7%), (2) a similar number for the Christian religion (around 54%) and (3) a higher number with another religion (Glasgow 7.5%, Scotland 2.6%). The number of Muslims in Glasgow (5.4%) is significantly above the national average (Scotland: 1.4%).
- 3.37 For Glasgow, the denominational split within the Christian religion is different from the Scotland position: 23.1% of Glasgow's population are "Church of Scotland" (Scotland: 32.4%), 27.3% are "Roman Catholic" (Scotland: 15.9%) and 4.1% are "Other Christian" (Scotland: 5.5%).




Figure 3.7 – Glasgow's Population by Religion and by Ethnicity in 2011

- 3.38 Figure 3.7 shows that the religious profile is very different for Glasgow's BME population, as compared with Glasgow's White population. The number of BME people with no religion (at 16.5%) is half the City average (at 31.0%). Only 19.8% of Glasgow's BME population belongs to the Christian religion (Glasgow: 54.4%), but 57.9% belongs to another religion (Glasgow: 7.5%).

3.39 The religious composition of the "Other White" population is more similar to that of the "British White" population in Glasgow. For the "Other White" population there are fewer people with no religion (24.3%, British White: 33.5%), and higher numbers for the Christian religion (64.7%, British White: 58.6%) and for other religions (3.6%, British White: 0.7%).





Figure 3.8 – Glasgow's BME Population by Religion in 2011

- 3.40 Figure 3.8 gives the religious profile of Glasgow's BME population. The largest group are "Muslim" (44.4%). Among the 19.8% who belong to the Christian religion, almost half are "Other Christian".
- 3.41 The change in the ethnic composition of Glasgow's BME population has had an impact on its' religious profile. The main change is an increase for those identifying as "Christian" (from 10.0% in 2001 to 19.8% in 2011) and a reduction for those identifying as "Muslim" (from 53.3% in 2001 to 44.4% in 2011).

- 3.42 Figure 3.9 (see previous page) shows that religious profiles are very different for the various ethnic groups in Glasgow.
- 3.43 The population share of "no religion" is highest for Chinese (68.3%) and "White Other British" (50.6%). The population shares for the various religions are highest for the following ethnic groups: for "Christian": "White Irish" (80.2%), "White Polish" (78.8%), African (62.2%) and "White Scottish" (59.6%); for "Muslim": Pakistani (93.0%), "Other ethnic Arab" (86.1%), "Bangladeshi" (75.5%) and "Other ethnic Other" (48.9%); for "Buddhist": Chinese (11.2%) and "Other Asian" (8.9%); for "Hindu" and "Sikh": Indian (38.9% and 30.3% respectively).

Population by National Identity




Figure 3.10 – Population in Glasgow by National Identity and by Ethnicity

3.44 Figure 3.10 gives a breakdown of the national identity distribution for ethnic groups in Glasgow. The "Scottish only" category has a Scottish identity only, the "Scottish plus" has a Scottish identity combined with another identity. The category "Rest UK" has an English, Welsh, Northern Irish and/or British identity, possibly combined with another non-Scottish identity. The category "Non-UK" has a Non-UK identity only.

- 3.45 80.3% of Glasgow's population consider themselves as having a Scottish identity (Scotland: 82.7%). 8.3% of Glasgow's population have only a non-UK identity (Scotland 4.4%).
- 3.46 The relatively higher numbers with only a non-UK identity in Glasgow is due to a higher proportion of people who belong to an ethnic minority.

- 3.47 Most of the "White Scottish" people (94.5%) consider themselves as having a Scottish identity. Among the "White Other British" this percentage is much lower (13.4%). 84.8% of the "White Other British" have a non-Scottish UK identity.
- 3.48 34.7% of Glasgow's BME population consider themselves as having a Scottish identity, 27.0% have a non-Scottish UK identity and 38.2% have only a non-UK identity. These figures are comparable with those for the BME population in Scotland.
- 3.49 The percentage with only a non-UK identity varies considerably by ethnicity (see Figure 3.10). The groups with the highest percentages of a non-UK identity are the "White Polish" (79.6%) and "White Other" (73.1%). The percentage is close to 50% for most of the Asian and African groups. Only 13.8% of Pakistani have a non-UK identity only.

Population by Country of Birth

- 3.50 The percentage of Glasgow's population born outside the UK rose from 5.7% in 2001 to 12.2% in 2011. In terms of numbers, this represents a rise of nearly 40,000, from 32,700 in 2001 to 72,600 in 2011.




Figure 3.11 – Population Change 2001-2011 in Glasgow by Ethnicity and by Country of Birth

- 3.51 Figure 3.11 (see below) shows that this rise is mainly due to the increase in the "Other White" and BME populations. The percentage "born abroad" is 69.6% for the "Other White" population and 62.5% for the BME population, as compared with only 1.2% for the "British White" population.

- 3.52 It is worth noting that the growth in Glasgow's BME population, at 37,200 in 2001-2011, is partly due to a rise of the BME population born in the UK, at 10,200 in 2001-2011 (see Figure 3.11).




Figure 3.12 - Population by Ethnicity and Country of Birth for Glasgow in 2011

- 3.53 The percentage of people born outside the UK varies considerably between ethnic groups, as is clear from Figure 3.12 below. The percentages "born abroad" are particularly high for the "White Polish" (at 90.6%), "White Other" (at 85.8%), "Other Asian" (at 84.3%), African (at 79.6%), "Other ethnic Arab" (at 77.6%), "Other ethnic Other" (at 76.6%) and Chinese ethnic groups (at 75.1%).

- 3.54 Pakistani and "Caribbean or Black" are more established communities, with lower percentages "born abroad": 43.7% for Pakistani and 49.9% for "Caribbean or Black".
- 3.55 The majority of "White Polish" and "White Other" groups come from the rest of Europe (see Figure 3.13). The situation is different for the BME groups: 15.9% of Glasgow's BME population were born in Africa and 43.7% were born in the Middle East or Asia.
- 3.56 The rise, for Glasgow, in the share of the population who are born outside the UK, from 5.7% in 2001 to 12.2% in 2011, compares with a rise, for Scotland, from 3.8% in 2001 to 7.0% in 2011.

Proficiency in English Language

- 3.57 0.4% (2,200) of Glasgow's population aged 3+ "has no skills in English" and 2.9% (16,500) "understands, but does not speak, read or write English". This compares with 0.2% of Scotland's population with "no skills in English" and 1.9% who "understand, but do not speak, read or write English".
- 3.58 For those born in "EU Accession countries April 2001 March 2011" the figures are higher: 3.4% (350) of the population aged 3 and over "has no skills in English" and 4.1% (400) "understands, but does not speak, read or write English". The following ethnic groups have significant numbers born in EU Accession countries: "White Polish" (89.2%), "White Other" (18.9%) and "White Gypsy/Travellers" (17.4%).
- 3.59 For those born in "Middle East or Asia" the figures are higher: 3.6% (1,100) of the population aged 3 and over "has no skills in English" and 2.4% (700) "understands, but does not speak, read or write English". The following ethnic groups have significant numbers born in Middle East or Asia: the Asian ethnic groups (around 58%) and the "Other Ethnic" groups (around 54%).

4 HEALTH

Health problem or disability

- 4.1 In 2011, 22.7% of Glasgow's population has a long term illness or disability. This limits day-to-day activities "a little" for 9.9% and "a lot" for 12.8% of the population.
- 4.2 Disability rates for Glasgow's population are higher than the Scottish average. In 2011, 19.6% of Scotland's population has a long term illness or disability. This limits day-to-day activities "a little" for 10.1% and "a lot" for 9.6% of the population.






Figure 4.1 – Population with a health problem or disability which limit their day-to-day activity by ethnicity for Glasgow in 2011

- 4.3 For Glasgow's BME population disability rates are around half the rates for the City (see Figure 4.1). In 2011, 10.5% of Glasgow's BME population has a long term illness or disability. This limits day-to-day activities "a little" for 5.8% and "a lot" for 4.7% of the population.

- 4.4 In 2011, 30.6% of Glasgow's population has one or more long term health condition(s). This compares with 29.5% of Scotland's population.
- 4.5 In Glasgow the percentage of the population with one or more long term health condition(s) is 33.5% for the "British White", 19.8% for the "Other White" and 15.2% for the BME population.

4.6 Figure 4.2 shows that for the "White Scottish", "White Irish" and "White Gypsy/Traveller" groups more than 30% of the population have one or more long term health condition(s). The "White Polish" have the lowest rate, at 9.3% of the population.

General Health

- 4.7 8.7% of Glasgow's population view their health as either "bad" or "very bad". This compares with 5.6% of Scotland's population.
- 4.8 Within Glasgow the percentage of those who view their health as "bad" or "very bad" is highest for the "British White" population (9.7%) and lower for the "Other White" population (4.2%) and BME population (3.7%).






Figure 4.3 – Population by General Health/Ethnicity for Glasgow in 2011

- 4.9 Figure 4.3 shows that the rates of poor health ("bad" or "very bad") are highest for "White Gypsy/Traveller" (14.0%) and "White Scottish" populations (10.0%).

Provision of Unpaid Care

- 4.10 9.1% of Glasgow's population provides unpaid care. This compares with 9.3% of Scotland's population.
- 4.11 Within Glasgow the percentage of those who provide unpaid care is highest for the "British White" population (9.8%) and lower for the "Other White" population (5.6%) and BME population (5.9%).

Observations from Scottish Government Paper

- 4.12 The data presented in this chapter may suggest that ethnic minorities enjoy a better health than the "British White" population. However, the effect of the younger age profile of Glasgow's ethnic minorities on their (relative) health must be taken into account before any conclusions can be drawn.
- 4.13 The Scottish Government paper: "Which ethnic groups have the poorest health?", referred to in paragraph 1.6, gives an analysis of health inequality and ethnicity in Scotland. To avoid the often misleading direct comparisons between populations with very different age structures, the analysis employed age-standardised rates to compare people of similar age.
- 4.14 Some of the key findings from that analysis are:
 - Most ethnic groups in Scotland reported better health than the "White Scottish" ethnic group;
 - "White Gypsy/Travellers" in Scotland had by far the worst health, reporting twice the "White Scottish" rate of "health problem or disability" and over three and a half times the "White Scottish" rate of "poor general health";
 - "White Polish" people aged under 65 reported relatively good health, whereas those aged 65 and over reported relatively poor health; and,
 - Across most ethnic groups, older men reported better health than older women. Older Indian, Pakistani and Bangladeshi women reported poor health and considerably worse health than older men in these ethnic groups.
- 4.15 It is not possible, with currently available data, to verify fully to what extent these findings also apply to Glasgow's population. However, as far as can be assessed, the findings are consistent with the results for Glasgow and there is no obvious reason why the findings may not also reflect Glasgow's situation.

5 HOUSING

Households by Type




Figure 5.1 – Households by Ethnicity/Type in Glasgow - changes 2001-2011

5.1 Figure 5.1 below gives the changes in the number of households by type. The first three categories ("single adult", "all students" and "all adults other") are "all adult" households and the last two ("lone parent family" and "other family") are family households *with dependent children*.

- 5.2 In Glasgow between 2001 and 2011 there was a rise of 18,200 in the number of "all-adult households", with rises for all three ethnic categories. In that period, the number of family households fell by 4,100: a fall of 10,400 for the "British White" households and a rise of 6,400 for the "Other White" and BME households. Figure 5.1 shows, for total households, a reduction in numbers for both lone parent and other families.
- 5.3 In Scotland the pattern is similar to Glasgow with a sizable rise in the number of "all adult households" and a fall in the number of family households in 2001-2011. However, the reduction in family households was only 1,000, with *a rise* in lone parent families and a fall in "other families".
- 5.4 Over 80% of the rise in single adult households (at 9,400 in 2001-2011) is accounted for by a rise in ethnic minority households ("Other White": 1,500 and BME: 6,100). More than half of the increase in "all-student" households (at 3,500 in 2001-2011) is due to rises in ethnic minority households ("Other White": 400 and BME: 1,500).

5.5 In Scotland, the rise in ethnic minority households has had a lesser impact, with only just over 20% of the rise in single person households due to this factor. For "all-student" households, the position of Glasgow is more similar to Scotland's position. In Scotland the ethnic minority households are responsible for over 60% of the rise in "all-student" household numbers.




Figure 5.2 – Households by Ethnicity and Type for Glasgow in 2011

5.7 43.1% of all households in Glasgow are single person households. The groups with the highest relative numbers of single person households are: "Caribbean or Black" (67.9%), African (48.7%) and "White Scottish" (44.6%). The numbers are much lower for Pakistani (19.2%), "White Polish" (24.4%), Indian (27.3%), Bangladeshi (27.9%) and Chinese (31.8%).

- 5.8 2.3% of households in Glasgow are "all-student" households. The figure is lowest (1.4%) for the "White Scottish" population. Groups with significantly higher relative numbers are the Chinese (18.8%), Bangladeshi (15.8%), Indian (9.3%), "White Other" (8.5%), "Other Asian" (7.8%) and "White Other British" (7.6%).
- 5.9 23.0% of households in Glasgow's are households with dependent children or families (lone parent and other). For the BME groups the percentage is much higher, at 38.1%. The percentage of families is highest among Pakistani (55.9%), "Other ethnic Arab" (46.5%), "Other ethnic Other" (36.7%), "White Polish" (36.0%), African (35.9%), "Other Asian" (34.5%) and Indian (33.4%).
- 5.10 Compared to Scotland, Glasgow has higher numbers of single adult households (43.1%, Scotland 34.7%), all student households (2.3%, Scotland 0.9%) and lone parent families (9.3%, Scotland 7.2%).




Figure 5.3 – All Adult Households by Ethnicity and Type for Glasgow in 2011






Figure 5.4 – Households with children by Ethnicity/Type for Glasgow in 2011

- 5.11 Further detail on the split by household type is given in Figure 5.3 (for adult households) and in Figure 5.4 (for families, see next page).

5.12 Pensioner households (the two categories "aged 65+ single adult" and "aged 65+ other") make up 22.0% of all adult households. Percentages are highest for "White Scottish" and "White Irish" populations (at around 25% of adult households). Given the younger age profiles of Glasgow's ethnic minorities, the percentage of pensioner households is much lower for these groups. Only 4.8% of adult households for the BME population are pensioner households.

- 5.13 "Other household type (not all 65+)" makes up 9.0% of adult households. Percentages are considerably higher for Chinese (32.8%), Bangladeshi (30.5%), Indian (26.6%), "White Polish" (25.9%) and "White Other" (22.2%). These represent households of adults without a family relation living together.
- 5.14 Compared to Scotland, Glasgow has fewer pensioner households (22.0% of all adult households, Scotland: 28.3%) and more non-pensioner single adult households (39.4% of all adult households, Scotland: 29.1%).
- 5.15 In Glasgow, 40.4% of households with dependent children are lone parent families (see Figure 5.4). The numbers of lone parent families are highest among "White Scottish" (45.3%), African (51.9%) and "Caribbean or Black" populations (55.5%). For the total BME population only 25.0% of family households are lone parent households. Among BME groups, numbers are lowest for the Asian and "Other ethnic" groups.
- 5.16 Compared to Scotland Glasgow has more lone parent families (40.4% of families, Scotland: 27.6%) and fewer married couple families (37.8% of families, Scotland: 52.2%).

Households by Tenure

5.17 In Glasgow, the total number of households rose by 14,100 between 2001 and 2011. Figure 5.5 shows a decline for the number of households in owner occupation (by -1,600) and in social renting (by -12,400). There was a sizable rise for the number of private rented households (+28,100)





5.18 40% of the rise in private rented households is due to rises for the "Other White" (+4,500) and BME (+6,600) population groups.




Figure 5.6 – Households by Ethnicity and by Tenure for Glasgow City in 2011

- Table 5.2 gives the households by tenure for the "British White"," Other White" 5.19 and BME groups and Figure 5.6 gives more detailed information: the household tenure profile for each of the ethnic minority groups.
- 5.20 45.6% of households in Glasgow in 2011 are in owner occupation. The percentages are much lower for "Other White" (35.3%) and BME groups (31.4%).

- 5.21 The groups with the highest owner occupation rates are: "White Irish" (54.7%), Pakistani (52.6%), "White Other British" (50.3%) and "White Scottish" (47.6%). The groups with the lowest rates are: African (7.2%), "White Polish" (11.3%), "Caribbean or Black" (23.0%) and "Other Ethnic" (22.5%).
- 5.22 36.7% of households in Glasgow in 2011 are in social rented accommodation. The percentages are lower for "Other White" (27.2%) and marginally lower for "BME" groups (33.9%).
- 5.23 The groups with the lowest rates of social renting are: Indian (10.5%), "White Other British" (15.7%) and "White Other" (16.8%). The groups with the highest rates are: African (69.1%), "White Polish" (50.8%), "Caribbean or Black" (45.3%) and "White Scottish" (38.8%).
- 5.24 17.7% of households in Glasgow in 2011 are private renters. The percentages are much higher for "Other White" (37.6%) and BME groups (34.7%).
- 5.25 Only 13.6% of the "White Scottish" households are in private renting. The groups with the highest rates are: "White Other" (54.4%), Indian (47.9%), "Other Asian" (42.0%) and "Other Ethnic" (41.3%).

5.26 Compared to Scotland, Glasgow has a smaller owner occupied sector (45.6% of all households, Scotland: 62.0%), a larger social rented sector (36.7%, Scotland: 24.3%) and a larger private rented sector (17.7%, Scotland: 13.7%).

Occupancy Rate

- 5.27 17.4% of households in Glasgow have an occupancy rating of -1 or less (which indicates overcrowding). This compares with 9.0% of households in Scotland.
- 5.28 Ethnic minorities in Glasgow are more likely to live in overcrowded accommodation (see Figure 5.7). Rates of overcrowding are over 30% for the Asian, African and "Other Ethnic" groups.

Central Heating


- 5.29 75.3% of households in Glasgow have gas central heating, 17.3% have electric heating and 4.0% have no central heating (in Scotland the respective percentages are: 74.2%, 13.4% and 2.3%).
- 5.30 62.8% of BME households in Glasgow have gas central heating. This compares with 76.5% of households for the White population. 47.7% of African households have gas central heating.
- 5.31 26.7% of BME households in Glasgow have electric central heating (or storage heaters). This compares with 16.4% of households for the White population. 41.1% of African households have electric central heating.

6 THE ECONOMY

Adults by Economic Status

6.1 Between 2001 and 2011, the population age 16 to 74 rose by 18,900 males and 8,000 females in Glasgow. Figure 6.1 shows that the number of people in employment rose by 44,700 (21,400 males and 23,300 females). The number of unemployed rose by 9,500 (4,200 males and 5,300 females) and the number of economically inactive fell by 27,300 (6,700 males and 20,600 females).

Figure 6.1 – Population age 16 to 74 by Economic Status in Glasgow – Changes 2001-2011



- 6.2 It is not possible to split these changes in economic status by ethnic group, because the 2001 Census Tables give the numbers for the age group 16-74 and the currently available 2011 Census Tables give the numbers by ethnicity for the age group 16 and over.
- 6.3 The numbers in the Figure 6.1 include Full-Time students. The Economic Status Tables from the 2011 Census make it possible to split the population into "Full-Time students" and "Rest of population" and to compare the ethnicity profile for these two groups separately (see next page, Table 6.1).
- 6.4 Excluding Full-Time students, the ethnic minority share of Glasgow's population is 15.0% in 2011 ("Other White" 5.1% and BME 9.9%). 36.4% of full time students resident in Glasgow belong to an ethnic minority ("Other White" 11.1% and BME 25.3%). Including the full time students in Glasgow's population increases the ethnic minority share to 17.3% ("Other White" 5.8% and BME 11.6%).

- 6.5 Figure 6.2 (see previous page) shows the ethnic groups with the highest relative numbers of students: "Other Asian" (46.6%), "Other ethnic group" (38.1%), African (35.3%) and "White Other" (35.0%). Only 9.1% of the "White Scottish" population are students.





Figure 6.3 – Males age 16+ (excluding students) by Ethnicity/Economic Status in Glasgow in 2011


Figure 6.4 – Females age 16+ (excluding students) by Ethnicity/Economic Status in Glasgow in 2011

- 6.6 In view of the wide variation in relative numbers of students by ethnic group, it was decided to exclude students from the comparison of economic status profiles for the various ethnic groups. The comparison is done for the population age 16+ for males and females (see Table 6.2 for amalgamated ethnic groups and Figures 6.3 and 6.4 for individual ethnic groups).

6.7 Economic activity rates are somewhat lower for the "British White" population, mainly due to more people in retirement or being "long term sick". This is likely to be affected by the older age profile for that population group.

- 6.8 Within the "British White" population, there are marked differences between the "White Scottish" and the "White Other British" populations (see Figures 6.3 and 6.4). For the "White Scottish" population, 56.6% of males and 51.6% of females are in employment. This compares with 74.3% of males and 70.1% of females for the "White Other British" population.
- 6.9 Economic activity rates are above average for the "**Other White**" population, mainly due to fewer people retired or "long term sick". For that population group there are significantly more people in full time employment or selfemployed and fewer male people are unemployed.
- 6.10 Within the "Other White" population the numbers in employment are highest for "White Polish" (males 89.5% and females 79.8%) and "White Other" (males 80.9% and females 72.0%). For the "White Irish" the numbers in employment are slightly above the City average, despite higher numbers of retired people. This is accounted for by fewer than average numbers of unemployed and "long term sick". Numbers in employment are relatively lower for the "White Gypsy/Travellers", due to higher numbers for "long term sick", "looking after home" and "other economically inactive". Of those in employment, a relatively high percentage are self-employed.
- 6.11 For the **BME population**, economic activity rates are considerably above average for males and slightly above average for females. Relatively fewer people are in full time employment, with more people self-employed, unemployed, "looking after home" and "other economically inactive". There are relatively fewer people retired or "long term sick".
- 6.12 The Mixed ethnic groups have a higher percentage of people in employment (males 74.5% and females 71.6%) and a low economic inactivity rate.
- 6.13 For many Asian groups there is a considerable difference between males and females for the percentage in employment. For Indian: males 80.1% and females 57.7%; for Pakistani: males 69.5% and females 31.4%; for "Other Asian": males 65.9% and females 48.5% and for "Other ethnic": males 59.5% and females 35.8% (City average: males 59.5% and females 52.5%).
- 6.14 Correspondingly, for these Asian groups there are relatively more females who "look after home" or are "other economically inactive". For Indian: 23.2%; for Pakistani: 47.0%; for "Other Asian": 33.7% and "Other ethnic groups": 43.8% (City average: 10.4%).
- 6.15 For the BME population fewer males are in full-time employment and numbers in part-time employment or self-employed are relatively higher. For Pakistani males: 29.7% are in full-time employment, 18.5% are in part-time employment and 21.3% are self-employed. The "Other Asian" and the "Other ethnic" groups show a somewhat similar profile. The percentage unemployed for "Other ethnic" is high for both males and females.

6.16 For the African and "Caribbean or Black" groups the pattern is very different from the Asian groups, with relative numbers of employed people close to the City average and higher numbers of unemployed for both males and females. For the African group the numbers in employment are 58.2% for males and 49.6% for females. Numbers unemployed are 25.7% for males and 18.8% for females. 26.4% of African females "look after home" or are "other economically inactive".



Qualifications

6.17 Figure 6.5 (see below) indicates that "Other White" and BME groups have, on average, higher qualifications than the "British White" population. It should be taken into account that students are included in these figures. Ethnic minorities tend to have larger numbers of students than the "British White" population. Another factor is the younger age profile of ethnic minorities, together with the fact that younger people tend to have more qualifications than older people. These factors could explain why for "Other White" and BME groups more people have higher qualifications. The same pattern can be observed for Scotland.





Socio-Economic Class and Occupation


- 6.18 It is clear from Figure 6.6 (on Socio-Economic class, see next page) that the BME rate is higher for full-time students (this was noted before) and for those who "never worked"/"long term unemployed". Numbers of unemployed were higher for BME groups, particularly the African and "Other Ethnic" groups. A higher BME percentage for small employers and own account workers is consistent with higher numbers of self-employed among some BME groups.
- 6.19 Figure 6.7 (see next page) gives the split White/BME by occupation for the population in employment and therefore it excludes the unemployed and economically inactive. BME groups, with the exception of African, do well in terms of population share for the managerial and professional occupations. The BME rate is high for sales and customer service occupations due to higher numbers from the Asian groups. Similarly, the BME rate is high for elementary occupations, due to higher numbers from the African group.

Figure 6.7 – Population age 16-74 in employment by occupation split by White/BME in Glasgow in 2011



Industry

- 6.20 BME rates are higher for the following industries: wholesale and retail trade (more Asian people), accommodation and food service activities (more Asian and other ethnic groups), information and communication (more Mixed and Asian groups), administrative and support service activities (more African and "Caribbean or Black" people) and human health and social work activities (more African and "Caribbean or Black" people).
- 6.21 BME people are under-represented in the following industries: manufacturing (fewer Asian and other BME people), construction, public administration and defence, and education (fewer Asian, African and Caribbean people).

Observations from Annual Review of Demographic Trends

- 6.22 As noted in the Introduction, see paragraph 1.3, National Records of Scotland have reduced some of the detail in the 2011 Census Tables, due to data confidentiality and associated disclosure control issues. As a result of this, the data presented in this chapter is more limited for some of the economic variables (e.g. Occupation and Industry).
- 6.23 The Registrar General's Annual Review of Demographic Trends in Scotland (2014), referred to in paragraph 1.6, contains, in chapter 11, a review of "How Scotland's Ethnic Groups fare in the Labour Market". The review is based on national data from the 2011 Census and, in addition to published Tables, makes use of special Tables for Scotland, which are not available at Council area level.

- 6.24 Some of the key findings from that analysis are:
 - "White Gypsy/Traveller" people were much more likely to have never worked or to work in elementary occupations;
 - "White Polish" people were the most economically active and were also most likely to be in lower skilled employment;
 - Indian people were the most likely to be highly qualified and to be working in the top professions; and,
 - African people were the most likely to be unemployed.
- 6.25 It is not possible, with currently available data, to verify fully to what extent these findings also apply to Glasgow's population. However, as far as can be assessed, the findings are consistent with the results for Glasgow and there is no obvious reason why the findings may not also reflect Glasgow's situation.
