We normally only make grant payments to legal guardians who receive Income Support, Income-based Jobseeker's Allowance, Working Tax Credit, Housing Benefit or Council Tax Benefit. We will only consider other claims in exceptional circumstances. We will usually pay grants into bank/building society accounts in July or August 2017.

PLEASE NOTE: What we will do with your information

Glasgow City Council is registered under the Data Protection Act 1998. The Council is under an obligation to manage public funds properly. Accordingly information that you provide will be used to ensure all sums due to the Council are paid timeously, e.g. by identifying persons who are non-payers of Council Tax and to improve uptake of benefits.
