Thank you for your email of 8 April below.

I'm happy to leave it with you to get back in touch when you feel it would be more productive to schedule another meeting, and once you have had time to consult and progress things at your end. There have been no revisions to the Council's proposed draft Heads of Terms so we look forward to taking the negotiations forward in due course.

With regards to your request for a proposed purchase price, a valuation of circa £80,000 was provided to you on 12 February by the Council's Property and Land Services. As set out in sections 11 and 12 of the <u>Guidance for Community Transfer Bodies</u>, the Act places a responsibility on Community Transfer Bodies to obtain their own valuation and advise the price they are prepared to offer for the asset. The Act states that the Relevant Authority then takes the decision whether to accept the price offered or not. On this point however, we would hope to continue our dialogue with you so that, as part of Heads of Terms, the price can be discussed and agreed.

How are you? Hoping all's well.

Having consulted with the Board here at Beatroute re:proposed Heads of Terms, and sought advice from various parties, we feel that we can only begin to negotiate agreeable Terms with the Council under legal guidance. This is of course costly for us, and so we must find a way to cover this expense, and others. We are planning on submitting a Stage 1 application to the Scottish Land Fund by mid-March, with a decision expected by mid-April. Only then can we begin to negotiate the proposed Terms, asset price and any proposed discount.

This of course means that the date you suggest of 12th April for a decision deadline won't be met, and so can I suggest that we negotiate a more workable date, which allows Beatroute time to seek the professional guidance needed in order to proceed?

Our Board have also looked at the proposed area of land to be transferred from the Council to Beatroute and have said that they do not wish to take ownership of any land out-with the green area delineated on the land plan you sent over. I'd imagine that this can be discussed alongside negotiations re: Heads of Terms though.

Hi Richard,

Many thanks for sending on the draft Terms. Have the Council decided on an agreeable sale price for the asset? That would help us to put this first draft of terms into some sort of perspective financially. If there is still uncertainty around the asset value, would the Council consider conducting a joint valuation with Beatroute Arts? We have received a quote from the D.V, Frances Hay and would be pursuing this line of enquiry in any case in order to obtain our own valuation. The DV office aren't available to carry out a valuation until April however, and it would take until April for us to secure the funding needed to carry out this work.

The SLF won't consider funding support to purchase of the asset at a Stage 2 application if excessive clawback terms are proposed, and this first Terms draft certainly seems to suggest as much, nor will OSCR allow us to go against the terms of our constitution. We're seeking some legal advice through COSS at present, and will need to speak with both the SLF and OSCR, so hope to come back to you soon with our thoughts on how to proceed. Until we have more clarity around proposed sale price and the flexibility of the proposed terms, it's hard to know whether the 12th April as decision date is going to be enough time. We must also consider the valuation timeframe when thinking about deadlines for agreement of Terms.
