NOT OFFICIAL **FB**: Consultation Paper was completed before Christmas for Motorways (M90) Hermiston Gait and the trialling of the single deck autonomous buses will be required to safely interact with other traffic in a live road environment. FB: Strategic business case; this involves transport investment, appraisal guidance following STAG for ministers to invest in, appraisal of different options, determining those options ie road scheme case, outline business case, design and development processes. FB: Transport modellers, reviewmethodology, sensitivity in testing, key issue: review impact on scheme, marginal, disbenefit; less roads for cars, increase journey space for buses. FB: Stakeholder Group: SPT, GCC and LA Officers onboard. FB: Climate change target, traditional metrics don't measure, further testing, what we are aiming for, research other modes (modal shift), review traffic conditions. FB: Assumptions; hard shoulder- Max speed limit: 40 mile an hour, benefits for buses. **FB**: Quantify schemes through assumptions.
