



Ongoing—Supplementary Guidance on the Green Belt & Green Network (SG6), to support policy CDP6 of the Plan, was issued for public consultation in early 2017. Once adopted, it will be used to help deliver a more integrated and multi-functional green network, including more opportunities for the provision of active travel routes. A draft Open Space Strategy for the City was published, for public consultation, in October 2018. To ensure both documents dovetail, consultation responses on both will be taken into account in revising SG6 with a view to adopting it later in 2019. In the meantime, Interim Planning Guidance (IPG6 and IPG12) is being used to support policy CDP6 and sets out how new development should help deliver a more integrated and multi-functional green network, including more opportunities for the provision of active travel routes.
