# (Traffic Management And Parking Controls) Order 2015 (Variation No 4) (Yorkhill Area And Radnor Street) Order 202

Glasgow City Council proposes to consider the introduction of the above-named Traffic Regulation Order in terms of the Road Traffic Regulation Act 1984, as amended.

The purpose of this Order is to enable the provision of permanent two-way cycle tracks on Gilbert Street, Haugh Road, Radnor Street, Sandyford Street and Yorkhill Street. The promotion of this Traffic Regulation Order will help to improve safety, accessibility and increase the use of active travel modes within the City.

### The roads affected by these proposals are bounded by:

Gilbert Street: From its western extremity to the extended west kerbline of Yorkhill Street

**Haugh Road:** From the extended east kerbline of Yorkhill Street to the extended southwest kerbline of Argyle Street

**Radnor Street:** From the extended northeast kerbline of Argyle Street to the extended southwest kerbline of Sauchiehall Street

**Sandyford Street:** From the extended south kerbline of Gilbert Street to its southern extremity

Yorkhill Street: From the extended north kerbline of Kelvinhaugh Street to the extended south kerbline of Old Dumbarton Road

# Details of the proposed Order

Prohibition of Being in a Two Way Cycle Track

#### **Gilbert Street**

 On the north side, from the extended west kerbline of Sandyford Street to the extended west kerbline of Yorkhill Street

#### Haugh Road

 On the northwest side, from the extended east kerbline of Yorkhill Street to the extended southwest kerbline of Argyle Street

#### Radnor Street

 On the southeast side, from the extended northeast kerbline of Argyle Street to the extended southwest kerbline of Sauchiehall Street

## Sandyford Street

· On the west side, from the extended south kerbline of Gilbert Street to its southern extremity

#### Yorkhill Street

 On the west side, from the extended north kerbline of Kelvinhaugh Street to the extended south kerbline of Old Dumbarton Road
