

**THE GLASGOW CITY COUNCIL
(HILLHEAD)
(TRAFFIC MANAGEMENT AND PARKING CONTROLS) ORDER 2022**

As a local resident / business, I write to advise you of the impending changes to the existing Hillhead parking control scheme.

The main features of these updated parking controls will be:

- Removal of Resident Permit Holder only parking bays
- Removal of Pay and Display only parking bays
- Introduction of Shared use parking bays in the place of the previously removed bays, for permit holders or those who wish to pay to park
- The chargeable hours for the shared use parking bays is Monday to Sunday, 8am to 10pm
- Those who wish to pay to park during these hours can do so for a maximum stay of 3 hours at a charge of 80p for 15 minutes up to 3 hours
- Resident parking permits at a cost of £85 per annum or £23.75 quarterly
- More than one resident parking permit now allowed per household
- Introduction of Business parking permits at a cost of £650 per annum, available to all businesses located within the Hillhead zone
- Introduction of Residents' visitors parking permits at a cost of £2 for a set 6 hour period, these permits are available to purchase in books of 5 vouchers for £10, each voucher covers a 6 hour period and up to 3 of these vouchers can be used on a single stay, to allow for visitors to stay for longer periods of time without interruption
- Resident and business permit holders can park without limit of time
- Enforceable disabled parking bays
- Enforceable motorcycle parking bays
- New Loading Only places Monday to Sunday, 8am to 10pm

The majority of the above changes are due to go live on **22 January 2024**. However the Council have a new permit system coming in on **12 December 2023**. Therefore from that date if you wish to renew your resident parking permit you can do so at www.glasgow.gov.uk

From that date you will also be able to purchase more than 1 parking permit per household, purchase business parking permits and apply for resident visitor parking permits.

Please do not attempt to apply for a permit prior to this as you will be unable to.

Programme of works

Signing

The signing works commenced on 30 October and are due to be complete by the end of the year.

Parking machines

Additional parking machines will be installed in the area. These will be existing machines brought in from another area and when initially installed they may be in a poor condition aesthetically. However once installed we will have them cleaned and repainted.

Lining Works

I can advise that the lining works for this area are due to commence in January 2024, weather permitting. Once we have a programme and any planned closures for these works the details will be posted on www.glasgow.gov.uk/Hillhead

There will be advance notice of these works with signs and notices, please adhere to these as it will be less disruptive to the local community if roads don't have to be closed twice.

It should be noted that road lining work is weather dependant which means that poor weather can cause delays. If this occurs or if other unforeseen issues arise then these works will be added to the end of the programme. Details of this will be made available as explained above.

I trust you find this information helpful and would like to thank you in advance for your patience while these works are undertaken. The Council will endeavour to complete these works efficiently and on schedule however I would apologise for any disruption that these works may cause.
