There should be teams in the community seeking out these young people to allow them to meet up in controlled environments, football pitches, clubs etc. I took my newborn out her first walk in her pram and it was horrific, dodging the broken glass all over every pavement, drug users eye balling you as you walk past, inhaling 2nd hand smoke from weed smokers, aggressive dogs off lead running up to us, 2 fire engines rushing to tend to what looked like a car that was set on fire, total dump of a place all in a 20 minute walk, this is what my baby is exposed to on our doorstep. I love my home but this area needs a miracle. All the work that has been carried out for years(!) and the place still floods when it rains, after a pooy boy lost his life during some of this work, and it all appears to have been for nothing. Heartbreaking. Sadly I do not see any improvement for this area and would leave today if it was an option financially.
