Local authorities such as Glasgow City Council would incur additional costs as a result of the Bill. That is made clear in Annex A of the FM which shows the total spend estimate for local authorities as £451,000 or 65% of the total cost of £694,500. Glasgow City Council would be likely to incur a higher proportion of that expenditure than other smaller authorities. Within existing funds it would be difficult to find sufficient resources to meet our obligations so additional funding from Scottish Government would be required.

As the author recognises, some costs are very difficult to estimate. We would agree with that but would request that more certainty on costs rather than assumptions should be provided to local authorities most likely to be affected by the Bill's provisions.

For example, while the development, promotion and implementation of Glasgow, as a whole or in part, as an area of linguistic significance (ALS) seems like an interesting possibility, the process to deliver that objective would likely be long and expensive. Likewise, the additional costs associated with the delivery of key issues like access to Gaelic Medium Education (GME), standards and GME assessments are not clear but we have to assume additional costs would be incurred by Glasgow City Council.
