## Part 1 of the Bill

1 Several reports, including the OECD Review of the Curriculum for Excellence and Professor Ken Muir's report "Putting Learners at the Centre. Towards a Future Vision for Scottish Education", have recommended reforming the current Scottish Qualifications Authority. How well do you think the Bill addresses the concerns raised in those reports?

The legislative changes will have limited impact unless there is a genuine change to the culture within the current organisation. The issues identified in the Stobart report, Mark Priestley's review and more recently in the Hayward report are not fully taken account of or addressed in the proposed legislation.

2 The Bill sets out measures designed to better involve learners, teachers and others in the new body's decision-making. What do you think about these measures?

The current body has various mechanisms through which stakeholders are supposed to influence decision making. However, these have not been effective and it is difficult to see how the proposals will significantly improve the current position whereby the senior leadership team benefit from narrative privilege. Once again, the core issue is the culture of the organisation and proposals which mean various bodies may come together on an occasional basis to scrutinise the work of that organisation while well intentioned are likely to have limited impact.

3 The Bill also creates several Charters, designed to let people know what they can expect when interacting with Qualifications Scotland. What is your view of these Charters?

Charters will not address the fundamental issues in our current high stakes exam system which results in the poorest young people in Scotland being disadvantaged. Unless there is a concerted effort to ensure no young person is disadvantaged on the basis of socioeconomic circumstances then charters will only advantage those with the social capital to be able to enforce their entitlement. The risk is that the organisation continues in its current form under new branding and the poorest continue to miss out.

#### Part 2 of the Bill

1 Part 2 of the Bill establishes the role of HM Chief Inspector of Education in Scotland, setting out what they will do and how they will operate. What are your views of these proposals? E.g. Do they allow for sufficient independence?

The role of HMCI is unlikely ever to be entirely independent as it is reasonable that they deliver on the will of the democratically elected Government of the day. However, the proposals go some way to ensuring greater independence and a distinction between policy development and inspection.

The reporting requirements appear reasonable, however an annual report will become onerous and may not show progress. A return to bi-annual reporting is more proportionate.
