Variation proposes to a) increase the terminal hour from 8.00pm to 10.00pm, Monday to Sunday; b) permit recorded music facilities within and outwith core licenced hours; c) add the following wording to further information, 'The premises may open for general trade prior to the commencement of core hours, but not usually before 7am. Recorded music may be played prior to the commencement of core hours. This is background level only.'; d) add the following to additional activities, 'The premises is a local convenience store and will therefore sell grocery items both during and out with core licensed hours, from 7am. The primary activity undertaken in the premises is the general retail sale of the following: groceries, confectionery, bread & cakes, crisps/snacks, non-foods, toiletries, frozen & chilled foods, fruit/vegetables/flowers, news & magazines, toys, tobacco & cigarettes, beers/wines/spirits and other alcoholic products, non alcoholic drinks. Charity collection point and charitable events take place. Food to go. Click & collect. Home deliveries. Paypoint payment. National lottery outlet. Sampling & promotional activities.'; e) amend the layout of the premises following a full internal reconfiguration; and f) increase the off sales capacity from 19.4m2 to 27.5m2.

Variation proposes to a) amend the layout of the premises by removing the external ramp at the front of the premises, increase the existing external area to the front of the premises from 8 persons to 14 persons and add an additional external area to the front of the premises to seat 20 persons; and b) increase the total external area capacity from 8 persons to 34 persons.

Variation proposes to a) add off sales facilities, Monday to Sunday, 11.00am to 10.00pm; b) permit children under adult supervision, access to the premises from opening until 9pm, or the duration of a family orientated function, young persons will be permitted access to the premises without adult supervision at the discretion of the duty manager until 11pm, or the duration of a family orientated function.; c) amend the layout of the premises to include an alcohol display capacity of 17.92m², erecting a separating wall with door creating two sections "Family Pub Area" and "Locals Pub Area", additional toilet facilities in the "Locals Pub Area", creation of indoor sporting areas within the "Locals Pub Area", alterations to fixed seating throughout the premises, the addition of a further external area and extension to existing external areas; and e) increase the external area capacity from 60 persons to 156 persons consisting of 20 persons to the front of the premises, 28 persons to the north side of the premises and 108 persons to the south side of the premises.
