- All dimensions are in metres and all levels are metres above Ordnance Datum unless noted otherwise.
 - Existing carriageway lane widths to be minimum 3.25m.
 - All setting out positions to be agreed on site by the Council Engineer.
 - All signing to be mounted on standard temporary 1050mm x 750mm sign frame, secured by 4 sandbags, unless otherwise stated.
- Proposed markings**
- Advisory cycle lane marking to DIAG 1004, 4000mm line, 2000mm gap, 100mm wide.
 - Cycle centre line marking to DIAG 1008, 4000mm line, 2000mm gap, 50mm wide.
 - Mandatory cycle lane marking to DIAG 1046B, 100mm wide (Temporary width).
 - Entry taper to cycle lane to DIAG 1009, 800mm line, 300mm gap, 150mm wide.
 - Lane through junction to DIAG 1010, 1000mm line, 1000mm gap, 100 wide (Temporary width).
- Proposed signs**
- Cycle symbol to DIAG 1007, -1215 X 750 for repeaters, -1700 X 2750 within ASL boxes.
 - Cycle direction arrows to DIAG 1009, 2000mm long.
 - Satellite Island
 - Drop Kerbs
 - Cycle lane kerbs - "Zebra" 13 Zero at 3.5m centres

- Existing carriageway markings to be burned off.
 - Existing carriageway markings to be refreshed/retained.

- Existing kerbs to be removed
