## Council Tax Exemption Application- All Occupiers Under 18 Years Of Age

In terms of schedule 11 of the Local Government Finance Act 1992, and the Council Tax (Exempt Dwellings) Scotland Order 1997 (as amended), a dwelling house may be exempt from Council Tax (including the water and sewerage charges) if it falls within the category shown below.

## An Occupied house:

Which is the sole or main residence of one or more persons under the age of 18 and of no other person.

Please complete the details on the attached form, sign the declaration and return to this office with supporting evidence.

Exemption will not be granted without supporting evidence. (See proof required)

## **Proof Required: -**

Verification of all occupiers ages by -

(1) Copy of Birth certificate. (2) Copy of Passport.

## Additional proof

- a. Copy of lease if property rented.
- b. If property is not rented provide me with the Name and current address of owner(s).
- c. If property is owned or leased by a member of your family confirm your relationship to them, i.e. parent, uncle etc., as well as their name and current address (if different from (b) above).
