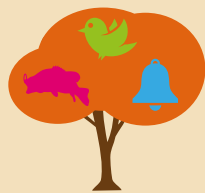


GLASGOW GREEN DEAL



Action Plan





Glasgow's Green Deal is a 9-year mission to transform the city's economy to tackle the climate and ecological emergency.

The council previously produced a high-level Green Deal roadmap which has now been taken forward into this document: our Action Plan and Outcomes Framework. This plan details the next steps we will take, in collaboration with key city stakeholders, to implement the Green Deal.

Green Deal Mission

Equitable, net zero carbon, climate resilient living by 2030

To support this mission, there are three inter-linked objectives:

1. Eliminate poverty and deliver justice through inclusion and equality
2. Reduce emissions and build climate resilience
3. Create prosperity, sustainable jobs and high-quality places.

There are eight key areas of focus where action is already underway but where significant acceleration in the pace and scale of delivery is needed:

- Maximising energy efficiency
- Increasing renewables deployment
- Clean, safe and connected mobility
- Tackling residual emissions
- Infrastructure and connectivity
- Conservation, restoration and valuing of nature
- Competitive industry and circular economy
- Adaptation and resilience

The following areas of work are levers of change with the potential to deliver wide-ranging positive change beyond their immediate focus. If used successfully, these levers can enable activity in each of the focus areas:

- Co-design, participation and inclusion
- Education, skills, training and capacity building
- Research, innovation and market-making
- Funding and finance
- Institutional and civic re-design
- Policy, powers and regulation
- Arts, culture and media
- Monitoring, evaluation, reflection and learning

This Action Plan is focused on direct delivery activity, as well as wider enabling activity to facilitate other council services and stakeholders across the city to play their role in the city's economic transition. It will be a living document, updated and expanded over time.

The plan sets out six outcomes that will be achieved by 2027 and the high-level activities that will be put in place by 2025 to achieve these.

Skills – Ensure a strong framework of support for all those affected by the transition to a net zero, climate resilient economy	6	Set up and support a Just Transition Working Group for the City Council
	7	Develop and run cross sectoral green skills programmes to support reskilling and upskilling in key industries including offsite manufacturing and construction, transport, district heating, housing retrofit and nature-based solutions
	8	Deliver the Just Transition Skills Action Plan so people are equipped with green economy skills, particularly those in jobs at risk from the impacts of climate change and the transition to a low carbon, climate resilient economy

Finance – Mobilise capital so the city can meet investment needs of the Glasgow Climate Plan and ensure wider flows are compatible with the Paris Agreement	9	Complete the study on the economics and financing of the Glasgow Green Deal
	10	Set out and agree the Climate Investment Framework for Glasgow
	11	Implement a green budgeting approach into the Council's budget process
	12	Set up a project development facility to support the development of business cases for climate investment
	13	Set up a blended finance facility for investment in Glasgow City Region
	14	Coordinate an investor dialogue and market engagement on the city's climate investment needs linked to actions in the Glasgow Climate Plan
	15	Develop and explore the role of a range of public-private partnerships in the city's climate finance investment needs linked to actions in the Glasgow Climate Plan
	16	Develop and issue a Community Municipal Investment linked to actions in the Glasgow Climate Plan
	17	Participate in the Cities Commission for Climate Investment (3Ci) to standardise the investment process for councils
18	Assess the viability of revenue raising powers from land value capture, with particular focus on a fund for new development and large-scale infrastructure projects

	20	Continue to develop a Climate-Smart Forest Economy Programme and associated forestry and construction value chains in Glasgow and the wider region
	21	Build on existing activity underway across the City Council and wider Glasgow to establish a market making approach to hydrogen with Council teams, Scottish and UK Governments and public/private sector partners

Mobilisation – mobilise a critical mass of businesses, community groups and citizens which support the transition and involve them in the politics needed for a new Green Economy	22	Develop a community mobilisation and involvement approach, based on systems maps of actors and their contributions to the Green Deal
	23	Develop and run a community grants programme to support development of the Green Economy
	24	Support the ongoing development of the action plan contained within the Circular Economy Route Map for harmful consumption, based around a new economic model of doughnut economics
	25	Develop and agree a clear city-level governance structure for the Green Economy, including the roles of Sustainable Glasgow, GEL, GPEG and other partner groups
