hundred and twenty six; With entry as at the Sixth day of April Two thousand and nine notwithstanding the date hereof; And we grant warrandice; And in granting these presents in return for the consideration aforesaid we hereby confirm and declare that in as much as we remain infeft or otherwise have right to the subjects and others hereby disposed we hold the same as trustees under an irrevocable and binding trust for our said disponees or their foresaids and subject to their directions until this Disposition shall have been registered in the Land Register of Scotland and we have herewith delivered these presents inclusive of this declaration of trust to our said disponees: IN WITNESS WHEREOF _____

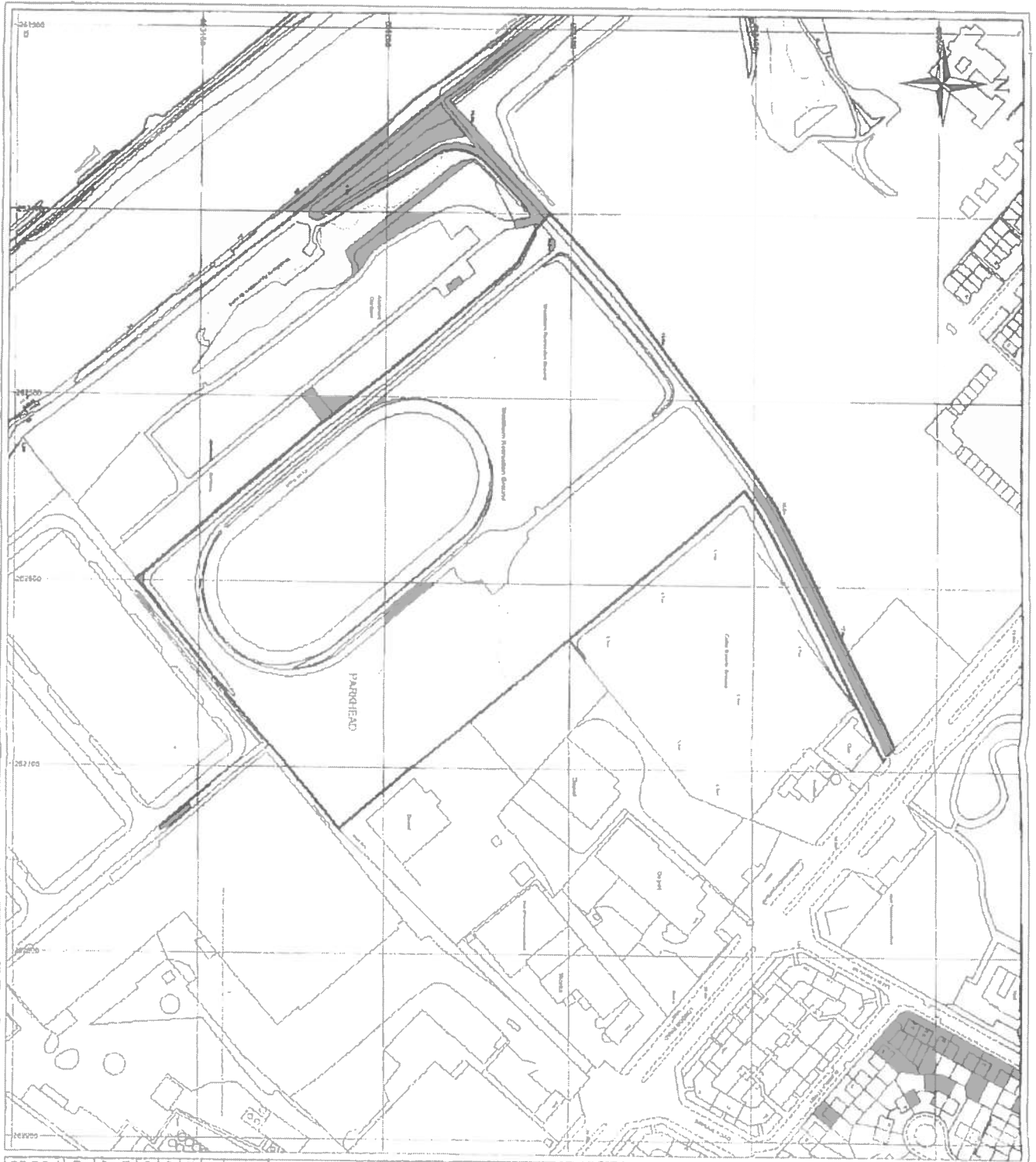
