Many thanks for coming in earlier today and sincere thanks for your wise counsel – we'll put it to good use.

I took a few notes, and as agreed, I'm pinging them round everyone you met today. If I've missed something – please fill in the blanks!

1. [REDACTED] gave an overview of Fanzone proposal. [REDACTED] and [REDACTED] advised the narrative should focus on the evolution of what was initially offered to fans on an ad hoc basis, to the current set-up and beyond. This latest proposal builds on the success of a limited offering and experience. It also helps focus a fair proportion of fans in a controlled, safe and attractive environment. [REDACTED] will also attend Dundee match on April 7<sup>th</sup> and we'll

arrange to show them the control room, current Fanzone and any other relevant aspects/people.

- (a) Fanzone Alcohol License should be for 'an area' rather than for booths/tents etc
- (b) We will be introduced to the Health/Safety/Event advisors Glasgow Life use. [REDACTED]
- (c) *"The Fanzone is an extension of the hospitality RFC currently offers within the Stadium"*.
- (d) Briefing of statutory bodies, Police etc should be held separately from Community Council + Elected members' meetings.
- (e) RFC to secure 3<sup>rd</sup> party endorsement of Community Council/Councillors etc help reinforce the proposal.
- (f) Comms Strategy: [REDACTED] to advise and forward strategies she was involved with.
- (g) [REDACTED] to introduce us to [REDACTED] – former employee of [REDACTED] and now works for [REDACTED]
- (h) RFC/[REDACTED] to incorporate the UEFA strap-line: SAFETY SECURITY SERVICE into the presentation.
- (i) [REDACTED] CV and experience as [REDACTED] at [REDACTED] to be highlighted along with other relevant professionals.
- (j) Once the idea of the semi-permanent solution is progressed – [REDACTED] and [REDACTED] to be informally briefed.
