If we go to a Sunday event I can work round setting up from 1pm on the Saturday - what time could we set up to - 8pm?

Can we use the access doors on the far side to get to the pitch - the two smaller single doors marked D&E on the Site Plan I sent you.

I have a pallet of water arriving on the Friday - can we bring it from the car park to a more secure area. We intend to distribute from within the building anyway.

Hi

Just wanting to close off on a few things re access to the Football Centre etc?

Assuming a Saturday Fanzone - may change for the first one to the Sunday as you already know – **Just to check on the date change, have RFC applied for the necessary licenses to cover the full weekend, not just the Sat 11<sup>th</sup>? I.e. the Occasional Alcohol Licence & Entertainment License (I know that part has**

still tbc).

Also – when is the earliest we will know a confirmed date so that we can make the customers/bookers aware?

1. We had talked about getting access to the pitch for set up from 10am on Friday 10th - is this still OK with you. Do I need a key to open up the pitch area? **We will arrange for someone to be on site that morning at Ibrox**
2. Can I arrange deliveries to the Car Park (fence, trakmats, etc) on the Friday 10th from 0800 - 1000) I will store them in one area. Hope to get them back to this area for uplifts on the Monday AM. **Yes, that is fine.**
3. Do you have any activities planned in the pitch for the Friday 10th August that I will have to work with - I am planning to get the food concessions, bar, stage, power set up. This will all eventually be off the pitch but I need to put the pitch covering down in certain areas to get it in. **There's nothing on the pitch until 6pm on Fridays. From 6pm onward we'd need to be cleared from the pitch area for football to take place.**
4. Do you have CCTV on the pitch area / car park etc - just thinking about Friday night into Saturday [REDACTED] **There is [REDACTED] at the [REDACTED] or [REDACTED] [REDACTED] had talked about moving the [REDACTED] etc?**

If the Event changes from the Saturday to the Sunday I would be looking at still getting the deliveries on the Friday and setting up as above on the Saturday - would this be OK with the same timings for access etc. **Deliveries are fine & setting up anything around the pitch is also fine but any actual set up ON the pitch would need to happen on Saturday after 1pm or the Sunday morning. If the Fanzone event is moved to the Sunday then I'd expect for Glasgow Sport to still be able to use the venue for business as normal on the Saturday. We currently have bookings on the pitch until 1pm on Saturday who I am stalling on informing whether or not they are being relocated to another venue. Once I get a confirmed date from RFC and/or a clearer picture from GCC licensing & G/Life Snr Mgt about our final stance on the matter of approval for the fanzone, I will communicate with those customers any impact.**
