As you are aware, we will not be running the proposed Fan Zone at the Ibrox Football Centre for the final four matches of the current season. This decision was taken due to the tight turnaround required for license (PEL & Alcohol) approval.

With this in mind, I wanted to put in writing and confirm our plan to host the 4 x match pilot Fan Zone at the Ibrox Football Centre for the start of next season subject to approval of our application(s). On recommendation, we have involved solicitors to aid fulfilment of this and will be engaging the necessary stakeholders in the coming weeks before submitting the formal license applications.

I'd like to stress here that the alcohol license application is ancillary to the PEL so regardless of the outcome of this application, we will look to progress with a public entertainment licensed space as originally planned.

As discussed, conscious we never received written confirmation form your team that the use of this space was approved - it would be great to have something in writing that communicates this? Subject to all necessary documentation (licenses, supplier information etc.) being provided by ourselves of course.
